*Western Washington's largest 3-on-3 tournament in its' fifth year of existence !!!*

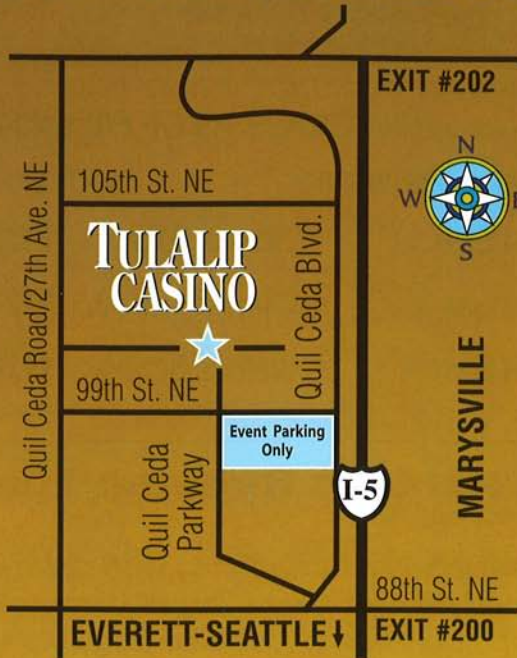

With all proceeds going to this 501c(3) non profit agency, it has certainly made a positive impact by helping to finance operations at our 13 Snohomish County clubs.

The event itself hosts some 250 teams, the largest event hosted at the Tulalip Casino. There are 20 different age and ability divisions; boys and girls grades 4 – 12, and collegiate men and woman thru senior groups. The two day event will capture the attention of up to 5000 spectators, with 20 games going on simultaneously, and there will be more food than even the most ardent fan could gulp down in a two-day sitting.

Volunteer workers are as critical to the event as basketballs and the weather. While paid officials from the Snohomish County Officials Association keep the peace on the courts, the 150 volunteer score keepers, result runners, and tournament assistants make the difference. It is these kind folks, both thru sponsorships or volunteering, that have made this tournament special enough to get front page news coverage in The Everett Herald, The Marysville Globe, and The Arlington Times.
